NOW THIS INDENTURE WITNESSETH AS FOLLOWS:-

Name of the Trust shall be :- **SALAR INFINITY MISSION (SIM)** Trust

The Registered Head office of the Trust shall be located at Vill & P.O.

India. The office of the Trust may be opened to any other place in

West Bengal or to any other of India or open local office or offices at places deemed necessary.

4. **INTERPRETATION:-**

a) Trust means the Trust created by this Deed Viz. **SALAR INFINITY MISSION (SIM)** Created by the Trustees to look after the whole organization i.e Mission, Vill & P.O. - Salar , P.S. - Salar, Dist - Murshidabad , PIN 742401 West Bengal, India. And other.

b) **TRUST PROPERTY** :- Shall include every kind of property movable and immovable to be owned by the Trust and mentioned in accounts, books and other documents in the possession, custody and control or that ought to be in possession, custody and control or possession of the Trust.

c) **AIMS AND OBJECTS OF THE TRUST :-**

The Trust is established for the following aims and objects, for Educational, Social, Economic and Cultural up-liftment and empowerment of the backward section in Indian Society, with special emphasis minority communities, and to conduct philanthropic and charitable activities in the area of operation of the trust and also for the general benefit of the society as a whole:

ANCILLIARIES

- a. To set up modern educational institutions to impart quality education at affordable rates, to cater to the backward sections of the society-especially minority communities,
- b. To promote, establish, start, maintain, organize, run, manage, supervise, superintendent, co-ordinance, Nursery to 10+2 English Medium School, Spoken English center, Cultural Programme, Mission, control, guide and grant aid to the hostels, laboratories, libraries, auditorium, and other educational institutions for the promotion of the arts, literatures, science and commerce.
- c. To set up educational institutions of higher learning and also of professional learning to mitigate the gap in these fields of education amongst minority communities,

- d. To set up institutions of research and Analysis to identify, analyze and formulate policy recommendations to address the socio - educational backwardness of minority communities.
- e. To set up high quality, modern coaching cum counseling centers to prepare meritorious students from Minority communities.
- f. To set up Leadership training centers for emerging/future leaders from Minority communities.
- g. To set up vocational training / skill up gradation centers for women.
- h. To commission studies and research in the fields of socio-educational up-liftment of backward sections of the society.
- i. To act as a co-coordinating agency at the national level, to liaison and co-ordinate with agencies and institutions working with similar objectives.
- j. To print and publish booklets, newsletters, books etc. by observing the rules and regulations for publications, in the above mentioned fields of activities,
- k. To set up Educational institutions encouraging medicine, science, technology, agricultural technology and technical education.

1. To foster and encourage education and training in handicrafts, among women fold in general.
- m. To award fellowship scholarship in case or in such other from on such terms and conditions as the trustees may think fit for the purposes of undertaking, prosecuting and encouraging studies provided that such scholarship and fellowship shall be awarded to poor and deserving students studying in schools, colleges and universities,
- n. To hold seminars, symposium, meeting, workshop and utilize audiovisual and other modern and technological aids and methods to achieve the above objectives.
- o. To do and arrange such other acts, deeds things, programmes and activities as may be incidental to necessities for the promotion and implementation of the above objectives.
- p. To run, maintain, manage and carry on the above mission for the purpose of education for the minority and backward people.
- q. To foster the ideal of spreading good education and provide quality education among the students of the mission, schools.
- r. To improve the standard of teaching and learning of the mission

- s. To hold and conduct examination among the students of the mission
- t. All aims/objects/purpose of the trust herein stated above shall come into effect/force after necessary approval of the competent govt. authority in the cases where affiliation / permission/license/ sanction is required.
- u. The trust will never act like micro financing and money Laundering (act 2012) in nature and shall not obtain any donation or like that from abroad without permission of FCRA ACT from the central Govt./the competent Govt. authority.
- v. The trust will never do acts which are illegal and unlawful in nature and also opposed to the public policy and contrary to the law of the country.

5. DEFINITION :-

- a. **"Trust"** means **"SALAR INFINITY MISSION (SIM)Trust** . in short **"SIM TRUST"**
- b. **"Board of Trustees or Trust Board"** means the body constituted and appointed in the Trust Deed as members of the Trust Board, which is empowered to manage all policy matters connected with the administration of the Trust.

c. **Founding Trustees** :- means those persons who originated the idea of forming this trust.

d. **Permanent Trustees** :- means those persons who will remain as trustee members for their life.

e. **Ordinary Trustees** :- are those members of the trustee board other than Founder trustees and permanent Trustees.

f. **"Financial year"** means the period of twelve months commencing from 1st April to 31st March of the following year.

g. **"Members"** means all those persons subscribing to the aims and objectives of the Trust and admitted with the approval of the Trustee Board.

6. **APPOINTMENT OF BOARD OF TRUSTEE:-** The following persons are appointed as the trustees of this Trust (hereinafter referred to as Board of Trustees or Trust Board):

7. MEMBERSHIP:-

The Trustees of the first part can propose the Chairman of the Trust and Trustees of the second part would propose the managing Trustee of the Trust.

This apart the Board Of trustees as per 3/4th majority decision may nominate members (as Ordinary Trustees, as against Founder and Permanent Trustees), In order to include persons of eminence who

would be helpful in achieving the objects of the Trust thus making the total number to a maximum of 21 (Twenty one) and such nominated persons above the number of 14 (Founding and Permanent Trustees) shall be ordinary members of the trust and without any voting rights, and for a maximum period of three years.

8. CANCELLATION OF MEMBERSHIP:- The Board of Trustees may take decision (3/4th majority of members with voting rights) to terminate any Ordinary Trustee(s) who acts against the interests of the Trust.

9. MEETINGS:- (1) Meeting of the Trustee Board shall be held at least twice a year. The first Meeting shall be held within one month after the registration of the Trust. Meeting of the Trust Board shall be chaired by the Charitman and in his absence, the managing Trustee and in the absence of the two, one of the senior trustee who are present and elected to chair the meeting.

(2) **Annual General Meeting-** There shall be one Annual general Meeting of the trust in the month of September or any other suitable month as may be decided by the Trustee Board for which 21 days notice shall be given to the members.

b. Announcements of changes in the office bearers/members and also auditors.

(3) Extra Ordinary General Meeting:-

a. EGM may be convened by the Chairman or by the Secretary when directed by the Trustee board who may decided of its own to consider some urgent and important mattes in the interest of the trust.

b. EMG may also be held on the requisition in writing of least three-fourths members who have voting rights, addressed to the secretary.

c. such three-fourths members may call such meeting themselves after due notice, if the secretary of the trust fails to convince such meeting on the requisition.

10. QUORUM AND MAJORITY:- For all meeting concerned with the day to day functioning and progression of the trust and the institutions under it, the quoeum shall be $3/4^{\text{th}}$ of the total members with voting rights; but for all matters related to policy decision meeting may be held with 60% of the total members with voting rights as the quorum, but in cases of emergency such meeting could be held with up to $3/4^{\text{th}}$ of the total members with voting rights as the quorum, I consolation with the absentee founding members over

phobe/ mail, and the minutes of such meeting should be countersigned by the absentee members at a later stage.

11. BOARD OF TRUSTEES

- A. The strength of the board of trustees shall be a minimum of 14 (FOURTEEN) There shall be a Chairman, a Managing trustee and Two Executive Directors in the Trustee board (all from amongst the founder/Permanent Trustee).
- b. The term (period) of the Board of Trustee, other than the fourteen permanent trustee board(if any), shall be 3 (three) years.
- i. **Chairman**:- Chairman shall be responsible for the general control and supervision of the trust. He shall act according to the Memorandum and articles of association of the trust.
- ii. **Managing Trustee**:- He shall be responsible for the day-to-day administration and functioning of the trust in person or by his representative. The Managing trustee shall be decided from amongst the signatories' number 2 and 3 on the 3rd page of this deed document or their selected heir or successor in rotation. The tenure of the managing trustee shall be three years and automatically one of the above two trustees shall succeed home in rotation. He shall represent the trust in all legal proceedings, courts and forums as per statutory requirements. he shall be a joint signatory for bank

operations along with chairman or any other trustee authorized by him. Settlers shall be the first managing trustee of this trust and shall continue for three years or till completion of the 1st project, whichever is later. S.L. No 2 & S.L. No 3 of the Trust will be fast signatories' for the first three years.

iii. **Executive Directors:** Besides the chairman and managing trustee the trust shall have two executive directors as its office bearers. The executive directors shall be responsible for the day to day functioning and administration of the trust, its properties and institutions, in consultation with the trustee board. The executive directors have to convene the meetings of the board of trustees in consultation with the chairman and the directors executive directors shall be responsible for maintaining minutes of the meetings. Sk. Abdul Quader shall be the executive director of the trust.

12. **POWERS AND DUTIES OF THE BOARD OF TRUST:-** As the apex body, the board of trust shall take policy decisions on all matters relating to functioning of the trust, its properties and institutions.

13. **ELECTIONS:-** A Terri will be a board of trust not exceeding 21 member including the 14 founding/permanent trustees.

The board of trust shall select the chairman and managing trustee, for day-to-day functioning of the trust.

The board of trust shall also select chairman of subcommittee(s) and its members, to supervise any specific projects/initiatives, from time to time, as required.

Only the fourteen(14) permanent members of the truest will have voting rights in all such eventualities(i.e. Ordinary members if any shall not have any voting rights)

14. FUNDING OF ORGANISATIONAL OPERATIONS:-

(From Indian source)

This organization as an NGO may draw its funds from internal as well as external source.

- A) Internal source
- i) Membership Contribution, ii) Local recourses
- B) External source

Within India (a) Grant in aid (from central or state Government)

15. **BANK ACCOUNTS:-** The bank accounts shall be opened in the name of the trust and operated by its chairman and managing trustee jointly or by their authorized signatory.

16. PROPERTIES OF THE TRUST:- Those assets acquired either as donation or brought for case shall be in the name and custody of the

trust all documents of the immovable or movable properties acquired by the trust shall be kept at the office of the trust. the income from the properties shall be used only for the benefit of the trust and no income or revenue shall be distributed among the members of this trust under any score. no member of the trust will receive any remuneration or allowance from the expenses incurred by them other than their investment in connection with activities of the trust , subject to the approval of the BOARD of trust.

17. **NOTICE OF MEETING:** - The executive director shall convene the meeting of the trust board and there shall be a minimum of 10 days notice for the meeting. in case of emergency the meeting can be convened in a short notice.

18. **ADMINISTRATION AND ANY DAY TO DAY MANAGEMENT OF THE TRUST:-** The board of trust shall frame necessary bye-law/rules and regulation of the day-y-to-day working of the trust and is empowered to add or delete any terms or conditions in the bye-law/rules and regulations by 3/4th majority decision.

19. **MAINTENANCE OF RECORDS AND BOOKS:-** The books and records of the trust shall be kept at the registered office the members have right to verify the records books of accounts etc. with the prior permission of the board of trust, if necessary the accounts of the

trust shall be regularly maintained every year and the accounts shall be closed by 31st march every year. the first year of closing shall be on 31st march 2019

20. AUDIT OF ACCOUNTS:- The accounts of the trust shall be audited by chartered accountant or otherwise qualifies accountant.

21. DISCHARGE OR RETIREMENT; REMOVAL OR DISMISSAL OF TRUSTEES/DIRECTORS:- The trustee/directors shall be discharged the event of death or on becoming insolvent or on tendering resignation which is duly accepted by the Board of trustee or for discharging any activity/activities detrimental or prejudicial to the interest of the trust.

Every trustee of the trust board is, however, liable to be removed from the Trusteeship on the charge of misconduct or on seriously jeopardizing the interest of the trust. Such removal will be made at a meeting of the trustees specially convened for the purpose after giving an opportunity of being heard to the said trustee.

22. UTILISATION OF INVESTMENT OF FUNDS AND INCOME OF THE TRUST :- The funds and income of the trust after defraying the expenses will solely be utilized towards the objects and no portion of it will be utilized for payment to the Trustees by way of profit/dividend/interest etc. The investments of the funds of the

Trust will be made in the forms or modes of investment in accordance with the provisions of section 11(5) read with section 13(1) (a) of the Income tax act or in accordance with the other provisions of the Income tax act which are in force from time to time.

23. **DISSOLUTION** :- In the event of dissolution, the assets remaining as on the dissolution shall not under any circumstances be distributed among the trustees / member of the Board, but the net assets if any after satisfying all the debt and liabilities shall either be transferred to societies/trusts having the same or similar or objects and which enjoy recognition under section 80G of the Income Tax or shall be vested with the government.

24. **ACT APPLICABLE**: - This trust is an governed by the provisions of the Indian Trusts Act(Act II of 1882)

25. **IRREVOCABILITY**: - This trust is an irrevocable trust and neither Trustees nor their descendants have any right or authority to revoke it. But the Trust Board by 3/4th majority of its members with voting rights shall have power to associate or amalgamate with other trusts/ societies constituted for similar purpose or to assign the Trust properties in favour of such other trusts.

26. **AMENDMENTS** :- No amendment of the Trust deed shall be made without the prior approval of the Commissioner of Income Tax

having the jurisdiction and no amendment shall be made to alter the objects of the Trust and further, no such amendments will be made repugnant to the provisions of section 2(15), 11, 13 and 80G of the Income Tax act.

27. CUSTODY OF DOCUMENTS :- All records, minute books, title-deeds, securities and investments, account books, voucher, papers and documents relating to the trust shall remain in joint custody with the chairman managing Trustee and Executive Directors at such place or places as the trustees may from time to time determine.

28. SUIT & LEGAL PROCEEDING :- The Board of Trustee shall be entitled to sue in the name of the Trust and may similarly be sued in the name of the trust.

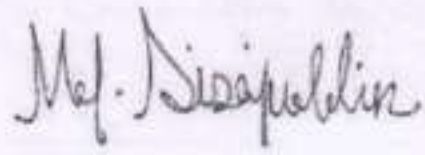
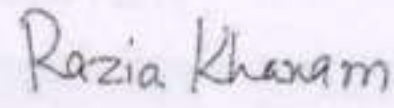

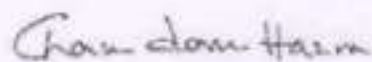
